# **Southern Piedmont Area of Narcotics Anonymous RCM Report**

**Report:**

**The N.C Region of Narcotics Anonymous met on Saturday, October 26, in Raeford, N.C. Eight of the eleven Areas in the Region were represented and I attended via Zoom. A copy of my SPANA Report is included in the Region Minutes attached.**

**Two changes to the Region policies were presented for review and approval by the Area GSRs. They included the removal of Section 6, Subsection 1 Business Issues: Item C under the Voting Policy in order to align with current practices. Elections are to be voted on by RCMs present at the Region meetings. Each RCM is to get only one vote with Regional officers to vote in case of ties.**

**In addition, a change was proposed to Section Six Voting: Subsection 1 Business Issues: Item E regarding expenses over budget that exceed \$500 in order to conform with Section Ten: Finance, Item B requesting that any money outside the budget exceeding \$500 must go back to the Areas for vote. Budget expenditures under \$500 will continue to be decided by the Region officers.**

**In other business, Rene N of the Down East Area has been nominated for the position of Region Chair and if approved by the Areas will assume the position at the next meeting in January. Rene has served as Down East Area RCM for the past year. Also, Jordan N was elected Secretary replacing Annette W. But a number of other Region positions are still vacant, including Vice Chairperson, Treasurer and Alternate Treasurer, H&I Chairperson, Alternate Secretary and Outreach Chairperson.**

**Anyone interested in any of these positions are asked to submit resumes by the January Region meeting including a recommendation from their Area.**

**The Region's insurance policy which covers home groups and facilities during special events was renewed with Philadelphia Indemnity Insurance at a cost of \$4326 for 2024-2025. Insurance certificates can be provided for one-time events, but do not cover full-sized conventions.**

**Two meeting groups in the N.C. Mountain Area have closed down as a result of Hurricane Helene damage. Also, the Region sent a delegation to the recent NA World Convention in Washington, DC. Their report is included in the Region minutes attached to this report. Reports from the Public Relations Committee and the Treasurer's Report are also attached. The PR Committee has developed a new QR code for the Region website which leads to a listing of all local meetings in the Region. The Region Treasury currently has a balance of \$5,788.46.**

**Finally, after I offered to host the meeting in Asheboro several times over the past year, the Region agreed to hold the January 18, 2025, meeting here at Keaton's Place.**

- ❖ If you are appointed or elected as a trusted servant and steal, misappropriate, or misuse property and/or money, your service commitment will be terminated, even if restitution is made.
- ❖ Further, it is agreed that if your service commitment is terminated for the aforementioned reasons, you will not be able to serve in any capacity on the Area Service Committee or any Area Subcommittee for a period of 3 years, pending a vote of confidence.
- ❖ Restitution must be made in accordance with the conscience of the Southern Piedmont Area Service Committee to preclude prosecution.
