Southern Piedmont Area of NA Theft Policy:

- ❖ If you are appointed or elected as a trusted servant and steal, misappropriate, or misuse property and /or money, you will be criminally and/or civilly prosecuted if restitution is not made.
- ❖ If you are appointed or elected as a trusted servant and steal, misappropriate, or misuse property and/or money, your service commitment will be terminated, even if restitution is made.
- ❖ Further, it is agreed that if your service commitment is terminated for the aforementioned reasons, you will not be able to serve in any capacity on the Area Service Committee or any Area Subcommittee for a period of 3 years, pending a vote of confidence.
- ❖ Restitution must be made in accordance with the conscience of the Southern Piedmont Area Service Committee to preclude prosecution.
